2. PUBLIC COMMENTS ON ITEMS ON THE AGENDA

Board president Gloria Ramos acknowledged the following retirees: Ms. Cason, Mr. Ibler, Ms. Greengard, Ms. Langer, Mr. O'Connor, Mr. Cooper, Mr. Brown, Ms. C De Baca, Ms. Duffy, Ms. Hafner, and Ms. Fernandez. She also recognized International Business Academy students with certificates: Kathy Givens, Arian Whitley, Natalie Banton, Jason Calvaros, Sandra Casias, Jonathan Cortes, Cecilia Cava, Omar Mola, Monica Robles, Nicole Shannon, Nicole Shaw and Victory Takian.

Lawndale HS PTA member Maria Salazar expressed her concern on Item D. Lawndale HS has the best API in the district and is a California Distinguished School; she stated that the PTA believes the district is leading Lawndale HS to be a Program Improvement school. She said that DAIT recommends CVUHSD get a system of accountability to hold principals, teachers and the district personnel accountable for student achievement. She agrees with the district that there should be concern over Leuzinger but that Lawndale is being sacrificed.

A Lawndale High School student spoke to the fact that she chose to go to Lawndale because it was the best high school in the district. She feels that the district is segregating teachers from the school and is leading the school in the wrong direction.

LaDonna Gaydosh, parent of Lawndale HS student addressed the teacher transfers issue asking to not break something that is not broken. She said if the district and board do not do something, the community will remember during re-elections.

Elida Sepulveda, volunteer parent spoke on behalf of Hawthorne High School. She asked that students who were 5-10 units shy of 200 necessary units who have signed an agreement to attend summer school to finish the units, and be able to walk at graduation. Second, she expressed her concern about losing their good teachers and not wanting them transferred, and said to fire the bad teachers and hire new, good teachers rather than take the good ones away from other schools.

Iliana Gonzales, Hawthorne High School student, spoke about her situation of having all the credits but did not pass CAHSEE, of which she failed the English portion and missing only one point, and wants equality for all seniors and to be able to walk on graduation.

Jose Gonzales, executive president of International Student Union, spoke on behalf of all senior students in the district who did not pass the CAHSEE. He asked that they be able to walk at graduation since a test cannot properly diagnose all they have learned throughout the years.

Julie Ichiroku, Lawndale High School teacher for 6 years, spoke to remind the board of a few things while making these transfers decisions in the next few weeks: Schools are communities of teachers, parents and students who rely on each other for success, removing any part of that will destroy the balance. The school is home to both students and teachers and being forced out of their homes, teachers will not perform to the best of their ability and will have a lot of bitter, resentful and angry teachers. All district schools pool from the same population—it's the programs, teachers, and past administrators that are the reason for Lawndale's success. Fixing Leuzinger while ruining Lawndale is not the solution.

Tali Sherman, Lawndale High School teacher, spoke about her concern for the lack of support by district administration for current and new academies. The academy coordinators who were interviewed over a month ago for the position were told they would be notified within the following week if they were hired. Today, seven days before school gets out, none of the academies have been told who their coordinator will be, none of the teachers who applied to the academies have been interviewed, and no work has been done to prepare for next school year.

Jaime Diego Chavez, counselor at Lawndale High School, has serious concerns discussed and made at the DAIT meeting, mainly the involuntary transfers of staff from Lawndale. He's been at Lawndale for 5 years, in education

meeting, mainly the involuntary transfers of staff from Lawndale. He's been at Lawndale for 5 years, in education for 17 years, and Lawndale has a group of great teachers because of the collaboration they've built, the school has succeeded because of these teachers and the great administrators. To create positive change and improvement in schools, the district needs to build trust and improve communication and collaboration with the teachers. He is now considering leaving the district because this is not what he signed up for.

Stephanie Aguila, Martha Elias, Adrian Castro, Clara Ibrahim, Brittany Jones, Chad Rice, Jasmin Hurtado (Lawndale High School students), Alana Rosales, Lazaro Garcia (Hawthorne HS students), all spoke regarding either the teacher transfers or the CAHSEE situation with regards to walking at graduation. They stated they are here to rally against teacher transfers. Lawndale is successful because of their amazing teachers that build great relationships with the students, and the students will continue to fight for the teachers until they are back at Lawndale and everything is the way it's supposed to be. To keep the academy programs running smoothly, everyone has to do their part or there will be no academies, if these teachers are moved, the academies will not be what they are today. Moving 30% of teachers has had a serious effect on school spirit, teachers are depressed with a changed attitude, and

it is affecting the teachers, parents and students. With regards to the CAHSEE, they all stated that they completed the requirements given by CVUHSD, 220 completed units and not passing this exam should not prohibit them from graduating. Some have called CAHSEE and learned that CVUHSD makes the decision of whether to graduate, so they are asking to graduate.

Dr. Susan Haynes, made reference to the Bible saying that when kings don't act like kings, God wipes them out. She asked not to denigrate, demoralize, and humiliate these teachers. She said the district is being cowardly and that is what people do when they know they're wrong. Dr. Hayes finished by reading a scripture from Proverbs. **Mrs. Kimberly,** a concerned parent, spoke about the CAHSEE and her child not being able to graduate because he didn't pass, even though he has completed the 220 units required by CVUHSD. Her son cannot pass this test, he has taken summer school, adult school, nothing works, and she doesn't know what else to do, but he has completed what was required by CVUHSD and believes he should be able to graduate.

3 STUDENT BOARD REPRESENTATIVES

Hawthorne High School student board representative **Victoria Skow**, named one of the top 25 graduating students, gave an update to all the senior activities taking place. She also mentioned the academies being recognized by Maxine Waters at an event held at the school. She asked not to cut the Yosemite student trip next year. She disputed allowing the students who are lacking credits the ability to walk at graduation as it isn't fair to those who completed all units.

Adrian Castro, student board representative at Lawndale High School, acknowledged students who were recognized and those accepted to Harvard, and all UC schools. He spoke about senior activities and mentioned that student morale is lowering every day because of the teacher transfers.

Student board representatives from Leuzinger High School, Lloyde High School, and CVISS were not present at the meeting.

5. ITEMS FROM CVSTA/CTA

CVSTA vice-president, **Betty Setterlund**, spoke on behalf of the teachers and counselors of the district saying they want to work together and their voices haven't been heard. DAIT process meetings were very informative and what Yvonne Contreras did say was that everyone needs to work together as a district. Each site is focused on itself rather than working together as a district. Teachers did not know that Leuzinger was struggling because there were not enough 10th graders passing the CAHSEE. The teachers cannot be blamed for that since he just found out, they were not aware of this issue. They have not seen this DAIT plan and pieces of it are being thrown at them. They want the 5 year plan on education. There are great teachers at every site. There have been extreme changes in the schools and that may be because of the huge rotation in site administration. Policy changes are top-down mandates, let the teachers in on the decisions so the policies last. Grades effect student motivation and the teachers need collaboration with the district. Teacher evaluations need to be done, at a given time. Trust needs to be built with district administration for the teachers. She said that recognition is important and asked everyone to take a moment to recognize students. Yvonne Contreras did say that the district has made great strides and everyone is proud of that. She acknowledged Ron Hacker and thanked him.

Pedro Martinez spoke about collaboration with the teachers who are possibly being transferred and the district. He asked that the collaboration be with the school departments and get them involved in the process.

6. COMMENTS FROM BOARD

Board member Maritza Molina thanked all the teachers who are present. She said that as alumni of Lawndale High School, she can say that the school has much more support now than it did then. She said it is important for the students to keep focused on their education and that is what will continue on.

Board clerk **Rocio Pizano** thanked the students for being there and expressing their opinions. She stated that she wasn't aware of the security issue addressed at Lloyde. She feels the board needs to get together with the DAIT team and the board needs to have more communication with the teachers union.

Board member **Hugo Rojas** thanked everyone for being here and expressing their views that have been heard in many ways. He spoke about the many challenges that are faced, especially at a state level. He hopes communication can remain open with the teachers union.

COMMENTS FROM BOARD (Continued)

Board president **Gloria Ramos** spoke about Lawndale High School and the fact that many factors play into what makes it so successful; it's not just one single factor. Lawndale High is a community, like a family and that makes the biggest difference. She appreciates the communication tonight and is happy that the anger didn't take over so that they could be heard. She spoke about the students who were lacking up to 10 units being able to walk at graduation, the same as the students who did not pass the CAHSEE, it is not cheapening the other students' education as they are not receiving a diploma, and they are simply being allowed to walk at their graduation. She thanked everyone for being here.

7. COMMENTS FROM SUPERINTENDENT

Superintendent **Jose Fernandez** showed a brief slideshow of the visit with Maxine Waters. He acknowledged her for being a friend to CVUHSD and the earmark that she carries, and gives us which is \$95,000 that qualifies us for \$500,000 of Dept. of Labor funds, most of which will go to the Engineering and Biomedical Academies and the rest will be spread to the other academies.

Mr. Fernandez stated that every student must have an equal right to equality in their education. Centinela Valley is a family, composed of 3 schools, students at each school are viewed by all as equals and they need to have equal access. CV has become a program improvement district and is not able to get out of that situation. Leuzinger and Hawthorne High Schools are program improvement schools. Those students now have the right to attend Lawndale HS which is not a program improvement school, which they have the right to do by federal law. Since the DAIT team was implemented 18 months ago, they have visited hundreds of classes and made many recommendations. He went over the chronology of events that led to the teacher transfers, including asking the teachers to transfer voluntarily, of which only 12 agreed to do and 74 refused. Dr. Contreras will be writing a report to the state in 6 months with recommendations, which could be that a trustee of the county of LA be appointed for Hawthorne & Leuzinger High School, or they could be turned into a charter school and the teachers wouldn't be looking at transfers, they would be looking at losing their jobs. That would be the loss of local control, and right now the district decides what happens and that needs to continue. Not knowing creates fear and fear creates anger. The district is trying very hard to minimize the impact to the teaching staff. They are looking at voluntary transfers first but, unfortunately, very few teachers were willing to transfer voluntarily, so involuntary transfers must be looked at. DAIT recommended transferring half of the staff, but the district is only transferring about one-fifth of teachers to keep the impact low. If he doesn't transfer the teachers, Dr. Contreras will recommend turning the schools over in that report in 6 months. If we do not act now, they will act for us and that will not be good.

8. PRESENTATION

A. International Business Academy

Presenter: Maria Eborn, Chair, IBA

IBA has a 98% graduation rate. They competed on an international level for virtual enterprises, creating a business plan, HR, Accounting, Marketing, etc., backed by a \$25,000 Mercer College grant, they have a virtual bank account and payroll with 42 other countries, over 5,500 businesses participating. IBA is invited to Austria next year for an international competition and the finals will be 2 weeks later in New York. SBWIB and El Camino College have offered to help with funding the trip. All of her seniors have been offered internships. Ms. Eborn recognized Natalie Benton and Daisy Sanchez for being offered an internship at Center for International Trade Development where they'll earn college credit. Ms. Eborn was recognized for her exemplary work preparing business students by the president of McGraw Education (owner of J.D. Power & Associates).
